OHK BAR & RESTAURANT POLICIES

- Weddings or vow renewals are <u>not</u> permitted in the restaurant. Please contact OHEKA Wedding/Event Sales for information on booking a wedding/event at weddings@oheka.com,events@oheka.com, or 631-659-1402.
- Bands, DJs, lighting, or decor are not permitted in the bar and restaurant.
- No outside food, beverages or alcohol permitted in the bar and restaurant or on the premises.
- Tables are for food service only.
- Guests may be restricted from entering the Formal Gardens, Library, Grand Ballroom, Terrace Room and other
 areas of the premises reserved for a Wedding Ceremony, Wedding/Event, Corporate Retreat or Film/Photo Shoot.
 Guests who violate this policy may be asked to leave thepremises.
- Guests are responsible for notifying OHEKA of any food allergies. While OHEKA makes every effort to identify ingredients and to train staff on food allergies and intolerance, OHEKA cannot 100% assure the ingredients of its food or beverage as manufacturers may change their product formulation or consistency of ingredients without OHEKA's knowledge. It is, therefore, ultimately the responsibility of the guest to judge whether or not to question ingredients or chooseto eat selected foods. All foods are prepared in an institutional cooking environment that could involve accidental contamination with the foods to which you or your guests may be allergic or intolerant. It is recommended guests carry medication or an Epipen. Client agrees to not hold OHEKA, its employees, and agents liable for injury, damages, expenses, or illness associated with the consumption of food or beverage provided by OHEKA. Food risk related to but not limited to this agreement are (a) choking, (b) allergic reactions, (c) poisoning,
 - (d) food intolerances or sensitivities, (e) upset stomach, (f) indigestion, (g) digestion, (h) nausea, or (i) diarrhea.
- No dogs are permitted in the Bar & Restaurant.
- Proper country club or business casual attire required at all times.
- Guests who do not honor these policies may be asked to leave the premises

OHK Personal Photography:

- OHK welcomes its patrons to take personal photographs in the bar and restaurant and, **if accessible on the day** and time of guest's visit, from public areas of the estate and garden, with the use of a handheld iPhone/Android Smartphone camera only (handheld cameras, professional equipment or accessories are prohibited).
- Access to the estate and gardens are <u>not</u> guaranteed on the day of your visit. If a Wedding, event or commercial
 shoot is taking place on the estate and/or in the gardens on the day of your visit personal photography will not be
 permitted. Note, Mansion Tours would not be available on these days.
- Loiterers are not permitted to take photos in any manner and will be asked to leave the premises.
- Maximum time in any one location is 5 minutes.
- No photographers (including friends or family, who are not patrons of OHEKA) may be brought onto the premises to take your personal photos.
- At no time may other guests be inconvenienced by being asked to wait or move to obtain a personal photo.
- OHEKA + OHK reserves the right to restrict guests from accessing areas of the estate and gardens at any time at its sole discretion.
- All images and videos taken by guests and visitors are allowed free of charge so long as the images and videos are used for a personal, non-commercial purpose.
- Photography which includes wardrobe changes, hair and makeup artists, a photographer, or other vendors
 (amateur or professional) will be considered a professional/commercial photoshoot. Any unauthorized
 photographer, videographer, makeup artists, stylist, or related vendors who are not guests of the hotel, estate or
 OHK will be asked to leave the property immediately.
- All camera accessories that could potentially impede foot traffic are expressly forbidden, including camera tripods, monopods, lighting setups, large reflectors, and staging shots.
- Furniture and furnishings may not be moved at any time.
- Only Wedding Couples getting married at OHEKA are permitted to take wedding photos on the estate and gardens on the day of their wedding.
- Photographs may not be published, sold, reproduced, transmitted, distributed, or otherwise commercially
 exploited in any manner whatsoever. All trademarks, service marks, logos, images, and facilities of OHEKA
 CASTLE are the sole property of OHEKA Management LLC and may not be used, reproduced, displayed, or
 distributed without written consent. OHEKA CASTLE has the right, at its sole discretion, to withhold or withdraw
 consent to photograph and video (or to reproduce photographs or video) of the estate and gardens.
- Professional/Commercial Photoshoots: Requests to use any area of the estate and gardens as a location for commercial photoshoots or filming should be directed to the Sales Department. These photo/video shoots are subjected to fees, insurance, and a strict schedule which must be approved by management. For professional/
